**Participation Request and Explanation Email:**

Good Afternoon,

Over the next several months, the Ocean Acidification and Hypoxia (OAH) Council will be honing the recommendations from our September 2018 Report (<https://www.oregonocean.info/index.php/ocean-acidification>) into the Oregon OAH Action Plan as requested by Governor Kate Brown. The Oregon OAH Action Plan will be critical for shaping Oregon's response to ocean acidification and hypoxia impacts, and will also be submitted to the International Alliance to Combat Ocean Acidification, as part of Oregon's founding-member commitment to the international community. In contrast to the comprehensive, recommendations described in the OAH Council's Report, the OAH Action Plan will identify a strategic set of short-term actions that Oregon will implement over the next 4-6 year period. We need your help to make the Action Plan process a success.

As you know, Oregon is among the first places in the world to observe direct impacts of OAH, due to our unique geographic and oceanographic context, putting our fragile marine ecosystem at risk. The development of the OAH Action Plan will aid Oregon in adapting to the projected changes in our environment. As part of a multifaceted community outreach strategy, the OAH Council is asking you to participate in the **OAH Community Survey**, an online questionnaire. Following the online survey (which is being sent to a few dozen professionals), the OAH Council will be conducting a series of one-on-one interviews as a way to capture more of the details about the expectations and advice on Oregon's next steps. Our September 2018 report, and the recommended actions within it, will serve as the jumping off point for both the survey and the follow-up interviews.

You have been selected to participate in the **OAH Community Survey** because of your expertise and your ability to help represent your colleagues' interests, concerns, and/or knowledge of OAH and how it will affect Oregon. This survey asks for your perceptions and opinions about Oregon's best opportunities to implement OAH mitigation and adaptation strategies.
