## Draft Meeting Summary – December 9, 2022

### Mill Casino Hotel & Remote Meeting

#### Issues Decided/Positions Taken

OPAC approved the following motions:

- The Draft Meeting Summary of the September 29, 2022 Ocean Policy Advisory Council (OPAC) was approved by consensus, without edits.
- The Council deliberated and acted to recommend all six sites which were being evaluated as part of the conclusion of the Rocky Habitat Management Strategy initial proposal process. Each site was discussed and acted on individually, and there were varying degrees of support which are documented in the list below.

Territorial Sea Plan Part Three site designation motions (with the vote count) in the order upon which the decision was made:

- Recommend designation of Ecola Point as a Marine Conservation Area (Vote: 9:1).
- Recommend designation of Chapman Point as a Marine Education Area (Supported by a consensus of the Council).
- Recommend designation of Cape Lookout as Marine Conservation Area (Vote: 8:2).
- Recommend Fogarty Creek as a Marine Conservation Area with an allowance of subtidal research with a preference for observational research (Vote: 8:1).
- Recommend Cape Foulweather Complex as a Marine Conservation Area with no change to commercial invertebrate harvest (Vote: 9:1).
- Recommend Blacklock Point as a Marine Conservation Area (Vote: 6:4).
