<u>General Updates</u> (from last meeting on Feb 11th, 2022) – Caren & Laurie 8:20am – 8:50am

- General updates from Caren Braby on the following:
 - PCC OA October 13-14 meeting- Request for Council members to RSVP to the event. Agenda will be sent out to council members and travel reimbursement is available.
 - Fisherman-Scientist Roundtable and Fisherman's App- App is currently being scoped by a Sea Grant Summer Scholar. The scope of the app is being designed. By the end of the summer, they could take the ideas to a programmer.
- General updates from Andy Lanier on the Ocean Policy Advisory Council (OPAC) -
 - OPAC/LCDC has finalized part 3 of Territorial Sea Plan that covers policy and designation of coastal management area in the intertidal and nearshore subtidal. OPAC has established a state policy to protect SAV from disturbance.
 - Andy provided updates on DLCD and the Climate-Friendly and Equitable Communities rulemaking process.

- General updates from Karina Nielsen ODEQ fellow is working on OAH water quality assessment methodologies, should release draft assessment methodologies for comment in Spring 2023.
- General update from Fran Recht Oregon Watershed Enhancement Board (OWEB) has received funding dollars for restoration in 3 coastal sites; money was just delivered
- General update from Laurie Juranek Laurie will be gone September and October on arctic oceanographic cruise

OAH Messaging Campaign Workshop Updates – Caren

- Council members discussed potential audiences of the communication plan.
 - It was concluded that more work needs to be done to refine target audience which could be completed informally at the PCC OA meeting October 13-14.
 - A proposed small working group of council members and Education and Outreach committee members could be formed to work directly with the communications team and determine a key audience.

Infographics update – Rhianna & Jenny

Jenny Koester and Rhianna Thurber voiced that they are currently reformatting OA and OH infographics to potentially use in the 2022 Biennial Report. An emphasis will be placed on communicating the detrimental economic impacts of OA and OH, the lack of research on species specific impacts to OA or OH, and the inconsistency in science on the impacts of OA and OH.

2022 Legislative Report Conversation and Edits - Rhianna & Jenny

- Council received first draft of the 2020 OAH legislative report on 7/26/2022
- Council members voiced their likes and dislikes of the draft report. Discussed modifications including:
 - Expanding the Executive summary and potentially adding a timeline infographic. Highlighting the success of HB3114 in the Executive Summary.
 - Emphasizing anticipated outcomes or potential impacts of the projects described in the Report. Adding more connective language throughout the document.
 - Revising the summary section for each theme to include examples of past successes and the implications of each theme.
 - Providing more detailed legends of scientific figures and selecting figures that are most demonstrative of OAH concepts.
